Please make sure Kim and the board receive this.

Thank you for making me laugh and for confirming what I suspected – that the board is letting Kim and FSR run the show and not meeting their legal obligations to act on our behalf.

Your letter also confirms that the secret meetings that the board had with Kim also makes her complicit to any risk and liability the association has incurred, because as you and she are aware – board meetings need to be open meetings, and ours weren't. Therefore, if you want to take this to court, please do, because it also gives me cause to challenge the validity of the contract and the payments we have made to FSR and make Jerry and company personally liable.

There wasn't any reason for the board to not sign the contract.

Your letter confirms that the board is representing Kim and FSR, not the association.

I have a right to ask questions and I have a right to get the information that I requested. It's the law, and the fact that you are supporting them in not complying with the law, also support my case that the board is working for Kim instead of advocating for us.

In addition to taking this to court, your letter also helps me to get the bar association involved – because you are encouraging and supporting them to not operate in a legal manner, but also the attorney general's office involved because as a nonprofit organization, the association as a legal obligation to do what is in OUR best interest, not in Kim's.

So, if they think I am taking up too much of their time in asking questions, they will be taking up more time once this goes to court, and when it does go to court, I plan to raise the issue that they need to pay their own attorney's fees, because they weren't representing the association when they made the choice to hide behind Kim's skirt.

There was not reason for the board to have closed meetings. Covid didn't make that law go away. As a management company, Kim knew that, and Kim should have provided them with options to make sure they were legally compliant, because as you have confirmed, Kim is running the show, not them.

I fully appreciate it that your letter is a smokescreen to allow FSR to not answer the questions I have been asking because they are difficult questions to answer, but we deserve better, and should this be necessary to take to court, exactly how many neighbors do you think there will be on Jerry and Kim's side of the aisle?

Please get Kim and the board to understand that encouraging them to not be legally compliant – by refusing to provide documents that I am legally entitled to see and know about, and by encouraging them the make decisions that benefit FSR in secret meetings that aren't legally compliant, as well, AND the fact that it can be construed as a huge conflict of interest for you to represent both Kim and the board isn't going to work well for anyone. As your letter confirms, there are also many conflict of interests with FSR and Kim running the show.

How soon can we go to court? Please get it on the docket soon.
